Afternoon Paul,

Further to the below, I have obtained Ted's comments regarding members from outside the UK. He commented as follows:

"1. On the application I agree with your approach. The less said, the better. Something very short on the lines of "We regret to inform you that your application has been refused. The Society understands that you are resident outside the United Kingdom and serving as a director of Hereford Herd Book International Ltd, an institution which the Society has sought to undermine its work. The Council has therefore determined that allowing you to join would be derogatory to the Society's character and/or prejudicial to its interests."

2. In order to ban non-UK residents from membership, I reckon you would need an amendment to the articles of association, not just the membership rules. Clause 4 of the AOA is quite open in terms of who can be a candidate. Clause 14 (which refers to "each Member resident in the United Kingdom") implies you can have members who aren't resident in the UK. So it is safest to look at doing this by amending the AOA, if that is what is desired."

I have had a quick look at your amended Articles and whilst the rules about who can be a member are still quite wide, I cannot see the same reference to residence in the UK. In any event the Articles are not yet adopted and it is sufficient to refuse the application on the basis of the connection with HHBI.

Please let me know if you would like to discuss this further. Please note, however, I am on holiday from close of business on Thursday returning on 20 July 2023.

Afternoon Paul.

Apologies for the slight delay, I hope the rest of the Cornwall show was good.

In terms of Mr Hall's email; the only requirement in the Articles is that "The Minutes of General Meetings of the Society shall be open to inspection of the Members at all reasonable times". As such, they are entitled to request them as Mr Hall has but there does not appear to be any requirement that they are actually circulated. Further there is no requirement for them to be available in a particular timescale. I would simply respond to say there is no requirement for you to circulate the minutes but that you will do so once they

have been signed off by the Council.

In terms of your query last week, regarding members from outside of the UK; rule 56 of the Society's rules sets out that:

"Under the provision of the articles of association, the council may remove any member whose conduct shall be, in its opinion, derogatory to the character or prejudicial to the interests of the society or who does not conform to the rules, regulations and bye-laws".

Further all members of the HCS, as a charity, owe it a fiduciary duty to act with 'single-minded loyalty' towards its objects.

In light of the above, it would be easy for us to refuse membership on the basis of the connection with HHBI, rather than location. I am happy to put together some brief wording for you if this would assist. I note that the HHBI website is still down but the company remains on Companies House.

I will also email Ted today to see whether he would have any concerns about changing the Societies' rules to exclude those who are outside of the UK.

Thank you for a copy of the draft minutes.

However, they do not correctly record the discussion at the meeting. Accordingly, I request please that they are corrected and the correct record forwarded to me.

1. Page 4, Lines 9 & 10 -

"Peter Hellen Hall asked why the Society is against the genetic test to identify the relation to North American ancestors".

Clearly this Minute is incomplete as it provides no context for the reader and incorrectly asserts that the North American derived animal is the ancestor to "something" that is not specified. Any Members reading these minutes is not provided with sufficient information to determine that the question relates to the genetic test that differentiates between the Hereford and its north American derived distant relation.

The minutes of the AGM are required to faithfully record / accurately reflect the question I asked. My question to the meeting was words to the effect:

"Why is the Society so resistant to the introduction of a cheap and simple genetic test (the HOP test) to differentiate the Hereford from the distantly related North American derived animal"

2. Page 4 Line 14:

"derivers"

The use of this word is at best confusing and does not clearly describe the fundamental point of my question. In this regard I refer you to the words I used in (1) above and request that that context be used.

The minutes of the AGM are required to faithfully record / accurately reflect the question I asked. My question to the meeting was words to the effect:

"Why is the Society so resistant to the introduction of a cheap and simple genetic test (the HOP test) to differentiate the Hereford from the distantly related North American derived animal "

3. Question 3.

The minutes of the AGM are required to faithfully record / accurately reflect the questions I asked. The Minutes do not report that I REPEATEDLY asked the question to the Directors and the Auditors, and the Directors and Auditor **REPEATEDLY** avoided answering / failed to answer the question. The question was words to the effect:

"What is the Board going to report to Company's House and the Charities Commission, as the reasons why the Annual Reports to the Company's House and the Charities Commission have been significantly incorrect / inaccurate for several years in that they have failed to correctly inform Company's House and the Charities Commission who the Directors and Trustees of the Hereford Cattle Society were / are for several years.

In addition.

While AGM Minutes obviously remain draft until they are adopted at the next AGM, time / currency is of the essence and the broader membership of the Hereford Cattle Society are entitled to receive up to date / current information about their Society. Minutes that are one year old are of little value to the Charity membership. Please advise when the full Membership of the Hereford Cattel Society can individually expect to receive their copy of the corrected draft minutes.
